## Schedule 2 – conditions to be amended

The following conditions are amended as a result of the application made by the operator

### 1.2 Permitted Wastes

#### 1.2/1: Permitted waste types and Quantities

No wastes other than those which are both categorised below and specified in detail in section 4.2 of the working plan shall be accepted at the site.

## Schedule 3 – conditions to be added

The following conditions are added following an Environment Agency initiated variation.

### 6.1 Fire prevention

6.1.4 The operator shall take all appropriate measures to prevent fires on site and minimise the risk of pollution from them including, but not limited to, those specified in any approved fire prevention plan.

6.1.5 The operator shall:

- (a) if notified by the Environment Agency that the activities are giving rise to a risk of fire, submit to the Environment Agency for approval within the period specified, a fire prevention plan which prevents fires and minimises the risk of pollution from fires;
- (b) implement the fire prevention plan, from the date of approval, unless otherwise agreed in writing by the Environment Agency.
